Eligibility

Any member of SoBA may enter one piece; 2 or 3 dimensional.

Conditions

- Pieces may be no larger than 36" in any direction, including frame.
- All work must be original. No prints or reproductions. All must be completed within the past 12 months.
- Artwork must be dry and professionally prepared for display. White mats only. Colored liners are acceptable. Wrapped canvases must be at least 1 ½" in depth with finished sides.
- All visual art media is accepted including photography/digital art.
- All work must be for sale and priced to sell. SoBA will retain a 35% commission of the stated price.

- Any work accepted for exhibition should not be removed until the end of the show. Drop off and pick up times will be only as stated.
- SoBA reserves the right to reject work that does not comply with these conditions or that is deemed unsuitable for public display.
- The show is limited to the first 100 entries. All participants are requested to sit at the gallery for one half day, date and time selected at entry on April 4.
- Entry fee: \$25 (check payable to SoBA)
